OACP Update

- **Bylaws Revision:** We have embarked on a complete revision to the OACP Bylaws, a multi-year effort to ensure the bylaws reflect current legal requirements and operating practices. A recommendation will be presented to the OACP Board of Directors in September during the Fall Conference at DPSST. If approved by the Board, the Bylaws proposal will be voted on by the General Membership for adoption. A draft of the Bylaws revision will be distributed to members in advance of the conference.
- **Budget Adopted by Board during June Meeting:** The changes include an increase in funding to the Scholarship Committee for college scholarships and conference scholarships for members (active and retired) based on need. The budget also includes a continued commitment to charitable contributions (Special Olympics, Lines for Life and Police Officer Memorial) and a new \$10,000 contribution to the Oregon Fallen Badge foundation to support the costs of planning and conducting a Line of Duty Death Memorial Service.
